**Reasons for Disqualification (D):**

1. Serious Foul Play
2. Violent Conduct
3. Spits at an Opponent or Any Other Person
4. Denies an Opponent a Goal or an Obvious Goal-Scoring Opportunity by Deliberately Handling the Ball. (This does not apply to a Goalkeeper in his/her own penalty area.)
5. Denies an Obvious Goal-Scoring Opportunity to an Opponent Moving Toward the Player's Goal by an Offense Punishable by a Free Kick Or Penalty Kick
6. Uses Offensive, Insulting or Abusive Language
7. Receives a Second Caution in the Same Match

**Reasons for Caution (C):**

1. Shows Unsporting Behavior
2. Shows Dissent by Word or Action
3. Persistently Infringes the Laws of the Game
4. Delays the Restart of Play
5. Fails to Respect the Required Distance When Play is Restarted with a Corner Kick or Free Kick
6. Enters or Reenters the Field of Play Without the Referee's Permission
7. Deliberately Leaves the Field of Play without the Referee's Permission
